SECTION A - DOCUMENTS TO BE SUBMITTED BY APPLICANT

CHC would require evidence of all other necessary consents and approvals (M.M.O, Crown Estates, etc.) being obtained prior to commencement of any works.

An electronic copy of technical drawing showing:

- a) Extent of area of harbour/river works to be licenced. Outline to be identified.
- b) Type of works description.
- c) Approximate area involved, in square metres.
- d) Detailed cross sections in particular to water frontages.
- e) Title.
- f) Drawing number.
- g) Two Ordnance Survey Grid Reference Points (if over land)
- h) Two Latitude and Longitude positions (if over water)
