PART III, ARTICLE 5 – LICENCE TO CONSTRUCT WORKS (TIDAL WATERS)

SECTION A – DOCUMENTS TO BE SUBMITTED BY APPLICANT

- CHC would require evidence of all other necessary consents and approvals (M.M.O, Crown Estates, etc.) being obtained prior to commencement of any works, where applicable.
- A record of the timeline for the works (Start Date, key milestones and predicted end date).
- An electronic copy of technical drawing showing:
 - a) Extent of area of harbour/river works to be licenced. Outline to be identified.
 - b) Type of works – description.
 - c) Approximate area involved, in square metres.
 - d) Drawing number.
 - e) At least two Ordnance Survey Grid Reference Points (if over land) or at least two Latitude and Longitude positions (if over water).
 - A copy of the Risk Assessment & Method Statement (RAMS) for the described works, please ensure to include any related hot work permits that may be required.
 - Names and details of any vessels that may be used during the works.
 - Outline of any on water or land-based support that may be required from CHC.
